OUT OF BOUNDS

Beyond all Hedges and Fences marking the Boundary of the Course.

Beyond the inside Points at Ground Level of the White Stakes on Holes 1st, 2nd, 3rd, 4th, 5th, 8th, 9th, 10th, 17th and 18th. (Rule 18.2)

PENALTY AREAS

Yellow Penalty Area (Marked with Yellow Lines or Yellow Stakes) and Red Penalty Area (Marked with Red Lines or Red Stakes) (Rules 17). Note there is no free relief from Bridges or other immovable artificial objects in the Penalty Area. (Rules 16.1a (2))

IMMOVABLE OBSTRUCTIONS

Includes all Fixed Sprinkler Heads, Manhole Covers, and Distance Markers, Staked Trees, and Artificially Surfaced Paths. (Rule 16.1) Please
